Loudoun County School closed

- **All GPS Programs** closed.

Loudoun County School opens one hour late

- **Kindergarten, Preschool and JK Extended** carline begins one hour later and classes end at their usual time.
- **Lunch Bunch** carline ends at its usual time.
- **Stay & Play** will open one hour later and end at its usual time.
- **After School Enrichment** begins and ends at its usual time.

Loudoun County School opens two hours late

- **Kindergarten and JK Extended** carline begins two hours later and classes end at their usual time.
- **Preschool** carline begins two hours later and classes end one hour later than their usual time.
- **Lunch Bunch** begins one hour later and ends at its usual time.
- **Stay & Play** will begin one hour later and end at its usual time.
- **After School Enrichment** is available at its usual time.

Loudoun County School closes one or two hours early

- **Kindergarten and JK Extended** classes end one or two hours earlier than their usual carline time.
- **Preschool** ends at its usual time.
- **Lunch Bunch** ends at 1pm
- **Stay & Play** ends at 1pm.
- **K-3rd After School Enrichment children** are **NOT** picked up from their elementary schools.
- **After School Enrichment** is not available.

If your child is in Stay & Play, Private GPS Kindergarten **with** After School Enrichment, or K-3rd (LCPS) After School Enrichment **and** you have purchased Golden Pond School's Snow Insurance, you will follow the protocol below.

Snow Insurance **must** be purchased in advance. The first payment is due on August 1, 2018.

Loudoun County Schools closed and Federal Government offers Unscheduled Leave/Telework or is closed

- ALL GPS Programs closed.

Loudoun County Schools open one or two hours late & Federal Government on time

- After School Enrichment (Private GPS Kindergarten only) and Stay & Play available at 7:30am.
- After School Enrichment (LCPS) available at usual time.

Loudoun County Schools closed & Federal Government on time

- After School Enrichment (GPS & LCPS) and Stay & Play available at 7:30am.

Loudoun County Schools closed & Federal Government open two hours late (Delayed Arrival)

- After School Enrichment (GPS & LCPS) and Stay & Play available at 9:30am.

Loudoun County Schools closed & Federal Government announces XX hours early dismissal

- After School Enrichment and Stay & Play will close accordingly. Please pick up your child promptly.

Loudoun County Schools close one or two hours early & Federal Government remains open

- After School Enrichment remains available.
- Stay & Play remains available.
- **ONLY K-3rd After School Enrichment children with Snow Insurance** will be picked up from their elementary schools and transported to GPS one or two hours early.

Golden Pond reserves the right to cancel school and/or the transportation of children after assessing road conditions for the safety of our students and teachers.
